



IN-HOUSE RULES OF THE PLAYGROUNDS OF HELECINE PROVINCIAL ESTATE

Article 1: The playgrounds are open from sunrise to sunset. However, the Estate's management may change these times, open or close the playground depending on weather conditions or other obligations and prevent access to certain playground equipment for safety reasons, without forewarning or indemnifying users.

Article 2: Entrance to playgrounds is free.

Article 3: There are two different playgrounds: one for the under 6s and one for children between 6 and 13.

Since these playgrounds are not supervised, children not accompanied by adults cannot use them. All groups must be accompanied by a designated adult in charge. This person is responsible for the discipline and safety of the group.

Any group that does not have a designated adult in charge will be asked to leave the playground enclosure.

Adults not accompanied by children and persons between 14 and 18 years cannot use the playground (administrative fine of €10.00).

Article 4: Over-agitated adults and children, likely to cause trouble, and those afflicted with contagious diseases, skin diseases or with open wounds are not admitted into the playground enclosure.

Persons who do not adhere to regulations, whose presence is undesirable and who do not follow the instructions given by the Estate's staff, may be ejected from the enclosure **without prior warning**.

Article 5: IT IS FORBIDDEN TO:

- Climb on the fencing surrounding the playground.
- Throw and leave litter on the ground and on the playground equipment.
- Bring drinks contained in glass bottles into the playground.
- Bring in animals, bicycles, radios, etc.
- Walk barefoot.

Article 6: For obvious safety reasons, **persons over 13 years are strictly forbidden** to use the playground equipment (administrative fine of €10.00).

Article 7: In an emergency, Management can impose other bans, pending a decision of the Standing Delegation of Walloon Brabant Provincial council.

Article 8: These playgrounds are managed by the Hélécine provincial estate, Avenue Armand Dewolf, 2, 1357 Hélécine.

This institution belongs to the province of Walloon Brabant, Avenue Einstein, 2, 1300 Wavre.

Article 9: Walloon Brabant provincial council will not be held liable for thefts, forgotten items, deterioration or disappearance of clothing or other personal items. Dry objects and clothing will be kept for one month, wet clothes for three days.

Accompanying adults are responsible for any damage caused by themselves or by the children they are in charge of. Where applicable, a damage report will be addressed to the person responsible by a sworn staff member of the Estate. The latter may demand for checking purposes presentation of the challenged person's ID document.

They will also work with Walloon Brabant Provincial Council to guarantee the safety of the playground.

Article 11: The visitor is required to adhere unreservedly to the in-house rules and the instructions given by any duly qualified staff member at the provincial estate Read and approved by the College of Walloon Brabant Provincial Council.
